Good morning Julie,

Thank you for your email.

Attached, I have provided an updated plan which shows in red a title owned by the Parish Council. The area shaded in blue is of relevance as it relates to land that is currently unregistered with HM Land Registry and we are unable to obtain details from them as to the owners or occupiers of the land. Our process to determine those with an interest in the land involves corresponding with the adjacent registered landowners to confirm whether they have ownership or an interest in the land.

The plans that you were sent (for unregistered952) display land that makes up part of the public highway, maintained by the local council. As the owner of adjacent land, we believe you may have an interest in the subsoil beneath the public highway up to half width. This is known as the 'ad medium filum' principle. 
